 - o simplification and harmonization of procedures
 - o ICT for customs modernization and data exchange
 - o risk management and post-entry audit
 - o Joint customs control
 - o Regional transit development
- Integrated Trade Facilitation
 - Corridor performance measurement and monitoring
 - CAREC Federation of Carrier and Forward Associations

Trade Facilitation- at the border

- WCO C21 Customs in the XXI Century
- Coordinated Border Management
- Joint Customs Control with PRC Customs
 - Manifest alignment at the Zamyn-Uud and Gashuunsukhait BCP's
 - Gashuunsukhait BCP: 18,299 manifests since 15 Dec 2011
 - Zamyn-Uud BCP: 110,000 manifests since 1 Jan 2011
 - Globally Networked Customs: Online exchange of manifest

Trade Facilitation-at border

- CAIS system-updated
 - Customs clearance, RM, web-based
 - ICT system developed inline with international requirements
 - Basis for national SEW
 - In operation since July 1, 2010
 - Exchange of e-documents both at domestic and international level became possible

Trade facilitation-behind border

- Supply chain security
 - Mining boom in Mongolia
 - Cross border issue of hazardous chemical products
 - The need for independent laboratories

Sub-regional issues

- Identical infrastructure and capacity of BCP's
 - Different level of infrastructure causing delays and bottlenecks
 - RIBS project
 - Sub-regional level solution needed
 - Building the mechanism of planning and information exchange in development of BCP's between neighboring countries
