









# Aid for Trade in Asia and the Pacific: Promoting Connectivity for Inclusive Development

## 7–8 February 2018 University of South Pacific, Suva, Fiji

Since the launch of the Aid for Trade (AfT) initiative, AfT has been an important part of ADB's support for regional cooperation and integration, and inclusive development in Asia and the Pacific. This conference will discuss key findings from ADB's 2017 Aid for Trade report.

Under the overarching theme of promoting connectivity for inclusive development, the event will review the latest trends in AfT disbursements and trade costs in the region, particularly for the geographically challenged sea-locked economies of the Pacific in a comparative Asian context. As intraregional trade and investment linkages, especially in the services sector, play an increasingly important role in promoting inclusive growth, the report also explores how AfT can be further leveraged to facilitate trade in services across Asia and the Pacific. Further discussion on institutional and regulatory reforms and cutting-edge trade facilitating solutions to promote trade in services and e-commerce would be welcome.

The event will bring together stakeholders from the Pacific, including policy makers, representatives from international organizations, the donor community, and academia to discuss the emerging challenges facing the remote island economies of the Pacific, and the way forward for the AfT initiative to boost connectivity and facilitate trade for inclusive growth. In the process, the discussion will also help highlight future intervention areas and inform the focus areas of ADB's 2019 Aid for Trade report.
