We aspire that the ATTN Forum will contribute to the discourse on managing the fast paced and constantly changing environment in the Asia Pacific region. The theme of this year's forum is *Digitization an Opportunity for Inclusive Growth in Asia and the Pacific*.

Ladies and gentlemen,

Digital transformation has gained significant attention in the last decade, driving productivity and inclusive economic growth, especially with post-covid surge in digital adoption across a wide range of socio-economic activities.

In Indonesia, the expanded digital economy could add up to USD2.8 trillion by 2040, boosting economic growth by an additional 11 percent over the next two decades.

The island of Java is expected to benefit the most, achieving growth rates of up to 6.65 percent between 2030-2040, compared to the baseline scenario of 5.88 percent. Meanwhile, Papua and Maluku are projected to see economic gains of up to 3.8 percent during the same decade, even with the adoption of new technology, up from 3.56 percent in the baseline scenario.²

The challenge is huge, but Indonesia has had a track record of achieving strong economic growth while narrowing the gaps between its regions.

Since 2001, the levels of income per capita, inequality, and poverty across the country's districts and municipalities have shown a trend toward convergence.

Indonesia's journey towards becoming a high-income nation by 2045 hinges on revitalizing its MSMEs, which contributed 61% of GDP and 97% of employment in 2019. Accessible, affordable technology solutions can play a crucial role³.

COVID-19 accelerated digital transformation⁴ by 3 to 4 years⁵. While some institutions thrived, others struggled or disappeared.
