Study Results



Study Findings

Azerbaijan increased its overall implementation of trade facilitation measures from 52% in 2015 to 75.3% in 2017.

Its level of implementation is significantly higher than the level of Asia-Pacific (50.4%) and the level of North and Central Asia (51.8%).

Among the six core groups of trade facilitation measures, **the most implemented** in Azerbaijan is "Institutional arrangement and cooperation" measures (88.9%).

The least implemented is "Cross-border paperless trade" measures (44.4%). For "Paperless trade", Azerbaijan's implementation is above both the regional and sub-regional averages.

Business Climate in Azerbaijan

The most remarkable positive trend is reported in the customs system, whereas productivity of employees is the factor with the most noticeable negative shift compared to 2016.

Strategic Roadmaps for development of national economy and main economic sectors (Dec 2016)

The access of local products and services into the foreign markets shall be encouraged through promotion of e-commerce solutions by developing e-commerce infrastructure and legal framework in line with international standards.

Protocols and techinical provision documents among customs administrations on electronic exchange of pre-arrival information have been secured



Good News

- e-Signatures to be mutually recognized under GUAM initiative, as well as among Turkic States and between Azerbaijan and Russian Federation
- Georgia, Azerbaijan and Kazakhstan are to launch a unified electronic transit document under ADB supported project
- EU NCTS is coming
- Digital Trade Hub to be extended

Study recommends

"....Azerbaijan may focus its trade facilitation efforts in particular on full implementation of "Formalities" measures, as well as on moving towards "Cross-border paperless trade", in particular through active participation in the new regional UN treaty on cross-border paperless trade facilitation."
